**NOTIFICATION**

In accordance with the Medical Council of India Notification No.MCI-31(1)/2010-Med/455, dated 19-04-2010 and on recommendation of Academic Council, in its 25<sup>th</sup> meeting held on 17<sup>th</sup> January 2018, Ref.No.BLDE(DU)/REG/AC/25/1/2017-18/1940, dated 22-01-2018 and Board of Management, in its 42<sup>nd</sup> meeting held on 25<sup>th</sup> January 2018, Ref.No.BLDE(DU)/REG/BoM/42/1/2017-18/2012 have approved the conduct of Supplementary Examination for MBBS Phase-I within 60 days of declaration of the main examination result. This will be applicable to the students admitted to MBBS course from the Academic Year 2018-19 onwards under the following conditions:

1. The results of regular MBBS Phase-I examinations will be announced within 14 days from the last practical examination.
2. Supplementary examination shall be conducted within 60 days of the declaration of MBBS Phase-I results of the regular examination.
3. The students who appeared and failed in the regular examination will be allowed to appear for supplementary examination.
4. The classes shall be conducted during the 60-days period and internal assessment examination will be conducted for such students to improve attendance and performance to be eligible to appear for the supplementary examination.
5. The students, though eligible could not appear regular examination due to unavoidable circumstances and those who were detained in the regular examination due to either shortage of attendance, by not less than 65% or internal assessment marks, may be permitted. They must attend the classes and improve attendance and performance to be eligible to appear for such examinations as per MCI regulations.
6. The fees for each subject will be charged as per regular examination fees.
7. Candidates, who fail in supplementary examination will have to appear in **main examination only**, for relevant subject/s, in the subsequent year along with regular batch.
