

IQAC will circulate the suggestions of the AAA for the department and ensure the compliance to the same

Strategies:

• Ensures the timely, efficient and progressive performance of an academic, administrative and financial tasks:

Calendar of Academic events is fixed and will be circulated well in advance to all the stakeholders and adherence to those events will be strictly complied with. Similarly, the administrative calendar of events is fixed, including the meetings of both Statutory and non-statutory Committees of the Institution. Also, the IQAC ensures to conduct at least three audits (AAA) and incorporate the suggestions given by them on a priority basis. IQAC ensures that the finance section will carry out both internal and external audits on time. This is to provide an optimal resource or financial management.

• Ensures relevant and quality academic/ research programs to be held at the level of Institution:

IQAC collects feedback on the curriculum and teaching-learning methods from the stakeholders. The same is being communicated to the relevant sections for the needful action. IQAC also evaluates the teachers with the help of the MEU, and it appreciates the teachers who excel in teaching and support the low performers to ensure the quality

IQAC regularly conducts workshops on research grant writing and Intellectual Property Rights (IPRs). The pre and post-test analysis score are used to enhance the quality of programs. BLDE (DU) supports quality research by providing the seed money and requisite training for the Faculty, Postgraduates in medicine and PhD scholars.

• It helps in the optimization and integration of modern methods of teaching and learning:

After conducting multiple meetings with various stakeholders, the current modern ICT facility is set in place. The faculty were trained to use different modern ICT tools, and the utility of the same is being evaluated. A state-of-the-art clinical skill laboratory has been established, and regular workshops for the staff, Postgraduates and Interns are being held. A virtual dissection table with a 3D representation of the structure, function of the various human organs/organ systems has been procured for the better student learning

• It helps to ensure the credibility of an assessment and evaluation process:

The examination process is framed so that it ensures the assessment of different aspects of learning. IQAC ensures the credibility of an assessment process by taking feedback from the students and external examiners. The question paper's confidentiality is being maintained by asking the students to pick one question paper among the three. All the 3 question papers are presented to him/her in a sealed envelope in the examination hall. Also, it ensures the results are unbiased by conducting double valuation (one by an Internal and one by an external examiner). If the difference between the two examiners is more than 15%, it will go to the third valuation. If the ambiguity persists, even 4th evaluation is being done.

• Equitable access to and affordability of academic programs for various sections of society:

IQAC suggested the waiver of fee to the meritorious students of the Vijayapura District, who gets a rank of <2000 in the Karnataka CET and scores better in BLDE University U.G. entrance examination. After the approval of BoM, it was effectively practiced till 2016. After the introduction of NEET, IQAC facilitates the poor students to join the Institution and counsel them regarding the availability of scholarships and educational loans.

• Ensuring the adequacy, maintenance and proper allocation of support structure and services:

IQAC, in consultation with the planning and monitoring board, makes the strategies and ensures it will be deployed and monitored effectively. Regularly, the Institution provides the annual maintenance charges to the concerned service providers, so that the assets/instruments within the organization are available to use at a given point.

IQAC has facilitated the examination section to have MoU with NSDL. Also, have MoU with National and International Institution for collaborative research.
