Hon'ble Vice-Chancellor briefed the Council about all the academic activities of the University in the past four months.

Dean Faculty of Medicine & Principal, briefed about upgradation of infrastructure of Hospital & various facilities like critical care services, etc. He also, briefed about the preparations done for MCI inspection and about visit of MCI on 28.03.2016.

### 3. For Discussion and Decision:

#### a. *Revision of UG/PG Curricula:*

Dr. Tejaswini Vallabha, Member of the Curriculum Committee, was requested to brief the process of curricula revision and highlight the revision of PG curricula. The process of revision was monitored by Eleven-Member Curriculum Committee for revision of curricula, including six external experts and Chaired by Dean FoM & Principal. To facilitate the process of revision of UG/PG Curricula, three Ad-hoc Committees – one for PG, one for UG and other for Integrated Teaching, were constituted.

The Ad-hoc Committee for revision of PG Curricula, Chaired by Dr Tejaswini Vallabha, compiled the inputs, including feedback and suggestions from Stake Holders, Mentors, Alumni and Subject Experts, from respective Board of Studies, deliberated on it and prepared draft PG curriculum for Degree and Diploma in 18 disciplines of broad specialty and one discipline of super specialty. On approval of respective Boards of Studies, the draft of PG Curricula is placed before the Academic Council. (**Enclosure-1**)

The main thrust of the revision was on incorporating recent advances and was focused on competency based teaching learning process and adding variety of tools in teaching, learning and assessment. There was consensus decision of Board of Studies to maintain the present evaluation pattern.

Prof. Tejaswini Vallabha mentioned that the Ad-hoc Committees for revision of UG curriculum and integrated teaching are being compiled along with the Boards of Studies inputs and feedback. On completion of the revision, the draft curricula will be brought before the Academic Council in the next meeting

**Resolution: Revised PG Curricula approved.**

- b. **Introduction of Fellowship in Minimal Access Surgery in Dept. of General Surgery:**  
Dr. Tejaswini Vallabha, Prof. & Head Dept. of Surgery briefed about the highlights of the course. The aim of the Fellowship in Minimal Access Surgery is to train a General Surgeon (M. S. Gen. Surgery) to be capable and competent to perform and practice minimally invasive surgery, in diligent and ethical manner. Any postgraduate with M.S. (General surgery) or DNB in is eligible to register for this program. The duration of the fellowship is one year. **(Enclosure: 3)**
