- b. **Distinguished Chair Professorship:**

The Controller of Examination informed the Council about introduction of 'Distinguished Chair Professorship; a new category of recognition for the teaching faculties in the University. Now, the University/Committee is proposing to nominate Prof. Kusal K. Das, Dept. of Physiology to be the first Distinguished Chair Professor in recognition of his distinguished and exemplary contribution to the field Physiology.

The council unanimously approved the nomination.

- c. **Gold Medals for UG and PG Students: Sponsors and Awardees:**

The Controller of Examinations briefed the Council about the award of list of Gold Medals and Cash Prize sponsored along with the name of the gold medal & cash prize winners.

- d. **Young and Senior Scientist Award:**

The Controller of Examinations informed the Council that on recommendation of the Committee constituted to select the Young Scientist and Senior Scientist Award, this year, Dr. Aruna Biradar, Assoc. Professor of Obstetrics and Gynecology and Dr. Lata Mullur, Professor of Physiology will be awarded Young and Senior Scientist Award respectively with a certificate and cash prize of Rs. 25,000/-.

i. **Revision of MBBS Phase – II curriculum:**

The Hon'ble Vice-Chancellor briefed the highlights of revised MBBS Phase – II curriculum as per directives of MCI to implement the competency based curriculum from the Academic Year 2020-21.

ii. **Revision of B. Sc. (MIT) Curriculum & intake:**

As per the University Regulations, once in every three years, the Curriculum has to be revised. Accordingly, the Curriculum Committee this year has revised the B. Sc. (MIT) curriculum by following the Choice Based Credit System (CBCS) and proposed to increase the intake from 15 to 20 seats per year from the Academic Year 2020-21.

The Academic Council unanimously accepted and recommended to BoM for its approval to implement the same from the Academic Year 2020-21.
