1. **Confirmation of the minutes of the, 20<sup>th</sup> (29.04.2016), 21<sup>st</sup> (25.10.2016) [Convocation] and Emergency (16.11.2016) Meetings:**

The Council in its 21<sup>st</sup> meeting held on 25.10.2016, approved UG Curriculum for MBBS Phase- I, recommended the names to the BOM to give assent to confer Degrees, Diplomas and Certificate to the candidates during upcoming Annual Convocation of the University, and also approved to give the Young Scientist Award to the Committee scrutinized & selected candidates.

In the Emergency Meeting of Academic Council held on 16.11.2016, the Council approved the AQAR -2015-16

- a. **Proceedings of 8<sup>th</sup> Meeting of Board of PG Teaching & Research:**

The Board of PG Teaching & Research in its 8<sup>th</sup> meeting approved Dr. Vanaja U Narsapur, Professor of Pharmacology and Dr. Girija Hanjagi, Associate Professor of OBGY as PG teachers and Dr. R. S. Bulagouda, Associate Professor of Anatomy as Ph.G. Guide.

- b. **Revision of UG Curriculum**

Prof. Yelikar, the Chairperson of Ad-Hoc Committee of Revision of UG Curriculum & HoD Pathology, presented to the Council, the process of Curriculum Revision and highlighted important changes in UG Curriculum.

Prof. Shivahalli asked whether policies of Ministry of Health and Family Welfare are being complied with & incorporated in the syllabus. Prof Tejjashwini Vallabha informed that the National Health Policies in relevant form and subject are incorporated as per Guidelines of MCI.

- c. **Establishment of Cadaver Laboratory- Report on visit to MSRIMS**

Dr. Tejaswini Vallabha, the Vice Principal, briefed the Council about the team visit to Cadaver Laboratory of MSRIMS Bangalore. She also informed about the steps initiated to set up the Cadaver Laboratory at the University. Prof. A. V. Patil made a presentation on Innovative experiments on Cadaver Dissections and hands on training for UG students.

*d. Proceedings of BOS meetings*

The Registrar read out the highlights of recommendations of Boards of Studies from the various Departments. Registrar requested the Council to authorize the Hon'ble Vice-Chancellor to approve the Minutes of BoS to conduct Post Academic Council meet.

The Hon'ble Vice-Chancellor requested the Heads of the Departments to refer the University Byelaws governing functions of BoS and modify according to the UGC (Deemed to be University) Regulations 2016, to make BoS more result oriented.

Prof. V D Patil suggested to include the innovations. Prof. Shivahalli emphasized on the Research Culture in Clinical side. In this regard, Hon'ble Vice-Chancellor informed that the University is taking steps and one such step is the Physiology Research Club. Prof. Das briefed about the progress of Laboratory of Vascular Physiology & Medicine, its units and the research work taken up. He also informed that two issues of University Journal have been published.

*e. State Conference on Environment and Child Health:*

The HoD Pediatrics, briefed about the State Conference on Environment and Child Health to be held in the month of September 2017.

*f. International workshop on Skull Based Surgery:*

HoD E.N.T. briefed about the International workshop on "Anterior & Lateral Skull based Live Surgery and Cadaver Demonstration" is scheduled to be organized on 25th to 26th May 2017.

He informed the Council that International Guest Faculty, Dr. Prepageran Narayana, Senior Professor & Consultant, Department of Otolaryngology and Head & Neck Surgery, University Malaya Medical Centre, Malaysia, will be the resource person at the workshop.

*g. UGC letters: the UGC communication received in past 3 months. The details of content and compliance are as follows:*

*i. Dated: 21.03.2017- Introducing identification mechanisms in student's certificates.*

The UGC, has asked the University to introduce the identification mechanisms like photograph and Unique ID/ Adhaar number in students' certificates. The Controller of Examinations informed the Council that BOE has resolved to incorporate, such identifications in certificate.

ii. *Dated: 15.03.2017- Upgradation of Syllabi*

The UGC is creating a database of Universities regarding revision of syllabi for its perusal. Hence in its letter dated 15.03.2017, UGC has requested to send the data regarding the upgradation of syllabi.

The University revises its curriculum once in three years. The data requested by UGC is been sent vide No: 31 dated: 04.04.2017

iii. *Dated: 09.03.2017 & 27.09.2016 - Hosting of Ph.D. Scholars data on website*

UGC requested the Universities to host the data pertaining to Ph.D. students in a prescribed format, on websites of University within two months.

The University is in the process of compiling the data, the same will be hosted on website shortly. The UGC has been informed accordingly.

iv. *Dated: 31.01.2017- Periodic Curriculum Revision*

The UGC, recommended the Universities to revise the Curricula at least once in three years to fulfill the needs of ever changing needs of various quarters of society and culture. Hence in its letter dated 31.01.2017,

The Vice Principal and Coordinator of the Curriculum Committee informed the Council that the University revises its curriculum once in three years. The same has been conveyed to UGC through letter vide No: 2326 dated: 28.02.2017

v. *Dated: 30.01.2017- Recommendation of journals to the existing list of UGC approved journals.*

UGC has notified the list of journals for the purpose of computation of API scores. It has requested the Universities to send the list of journals subject- wise, which are not included in the UGC list of journals already notified by the UGC.

The University has submitted the list of journals to the UGC vide letter no: 2351 dated: 02.03.2017

vi. *Dated: 27.09.2016- Introduction of MOOCs courses through SWAYAM Platform*

UGC has uploaded the list of MOOCs courses on its website and has requested to the Universities to take appropriate action for introduction of MOOCs courses through SWAYAM platform of Government of India.

The University has placed all the three letter of UGC regarding MOOCs courses before the Council.



Prof. V D Patil informed the Council that, the MOOCs courses are not applicable to Deemed to be Universities, as these will contravene the UGC Regulations 2016, clause for off-shore campus.

The UGC has requested the University to advise the students to register themselves on the NDL portal to access the National Digital repositories, through single window.

The UGC asked the University to implement the Choice Based Credit System (CBCS).

The Vice Principal informed Council that, the Ph.D. Committee has introduced CBCS for Pre-Ph.D. course examinations.

ix. *Dated: 19.05.2016- Awarding of degrees in 180 days*

The UGC requested to follow the UGC regulations 2008 to in awarding of degrees within 180 days of the date by which the students are expected to qualify and become eligible for them.

The University has replied to UGC vide letter 1451 dated 22.09.2016 mentioning that it abides by the UGC regulations in awarding the degrees.
