- 1. For Consideration and Decision:
 - a. Inclusion of Pharmacy, Nursing and Ayurveda disciplines in the Ph. D. programme under the faculty of Allied Health Sciences:

The Committee deliberated on the matter and opined that as per UGC Regulations 2018 governing Ph. D. programme, the said faculty can be included in Allied Health Sciences.

The Hon'ble Vice-Chancellor suggested that the eligible Faculty Members from Pharmacy, Nursing and Ayurveda may be recognized as a Co-Guide for such Ph. D. students.

In view of strengthening of Ph. D. programme of University the Committee resolved to include these disciplines in Ph. D. programme.

Resolution: Approved and recommended to BoM.

b. Starting new course: Master of Hospital Administration and Master of Public Health:

It is proposed to start the course in Master of Hospital Administration and Master of Public Health. The course curricula, evaluation, following the Choice Based Credit System (CBCS) and other modalities were discussed.

The Committee deliberated on the matter and recommended to BoM for approval.

2. Any other matter with permission of the Chair:

a. Setting up of Department, nomination of Dean of Faculty and constitution of BoS of Allied Health Sciences:

The Council discussed the means and ways for setting up of Department of Allied Health Sciences. The Committee decided to nominate a Senior Faculty Member from Allied Health Sciences as a Dean of the Faculty and to constitute the Board Studies of Allied Health Sciences.

The Hon'ble Vice-Chancellor assured the Council that on detailed discussion with experts the modalities will be worked out.

b. Appointment of Adjunct Faculty (Professor/Assoc. Professor/Asst. Professor) from other disciplines:

The Hon'ble Vice-Chancellor while sharing the suggestions of Prof. Kokate, Former Vice Chancellor of KLE, expressed the need of efforts to enhance the number of publications. A step towards it shall be appointing the Faculty Members of Pharmacy, Nursing, Ayurveda, Engineering and Science disciplines as an Adjunct Faculty Member as per eligibility as Professor, Assoc. Professor and Asst. Professor. The Council unanimously accepted the suggestions.

Resolution: Accepted and recommended to BoM for approval.

c. Appointing Prof. Akamanchi as an Adjunct Professor:

Prof. K. G. Akamanchi, who retired as Professor of Pharmaceutical Chemistry from UDCT, Mumbai, has been a researcher of repute, richly experienced in research, industrial linkages and patents.

The Committee deliberated on the matter and decided to appoint him as Adjunct Professor in Allied Health Sciences to utilize his expertise.

Resolution: Accepted.

d. Incentive for publication of case report, etc.:

As a major step to bolster annual output of research publications, Committee decided to give an incentive of Rs. 5,000/- for case reports, letters to editor and editorial provided it is indexed in Scopus / web of Science / PubMed.
