- 3. Describe indications and methods for fluid and electrolyte replacement therapy including blood transfusion
- 4.Describe common malignancies in the country and their management including Prevention
- 5. Identify social, economic, environmental and emotional determinants in a given case, and take them into account for planning therapeutic measures.
- 6.Recognize conditions that may be outside the area of his specialty, competence and to refer them to the proper specialties.
 - 7. Update oneself by self study and by attending course, conferences and seminars relevant to the specialty.
 - 8. Teach and guide his team, colleagues and other students.
- 9.Undertake audit, use information technology tools and carry out research, both basic and clinical, with the aim of publishing his work and presenting his work at various scientific fora.
