#### **Terms of reference:**

- i. To receive and consider the complaints received on the above subject occurred from the staff within the University campus.
- ii. To summon the officials to dispose before the committee.
- iii. To record the statement of the complainants and respondents.
- iv. To recommend the steps to be taken to eliminate the sexual harassment & prevent the violence of the women in working place.
- v. To submit the Annual Report on the complaints received and action taken.
- vi. To recommend the appropriate penalty etc.

The committee shall meet as & when required.

Not less than 4 with at least two female members present during the meeting.

The Committee shall report directly to the Vice Chancellor of the University. The Committee shall submit the report on the complaints received on the sexual harassment within 30 days of complaints received, along with its recommendations.
