1. The Occupier of M/s. Shri B.M. Patil Medical College, Hospital & Research Centre., is hereby granted an authorization to operate a facility for Generation, Collection, Reception, Storage, Transportation, Treatment health care, Disposal of Bio-Medical Waste in the premises situated at BLDE Road, 30/A, Mahalbagayat, Vijayapura- 586103.
2. This is an authorization granted for bed strength of 940 numbers for Generation, Collection, Reception, Storage, Transportation of the following categories of Bio-Medical Waste for treatment and disposal as indicated under Col.No.3.

10	Chemical waste	Liquid chemical waste shall be treated by chemical treatment & solid chemical waste shall be sent to secured landfill.

3. This authorization granted for a period from 01.07.2015 to 30.06.2018.
4. It is the duty of every occupier to ensure that, all the biomedical waste generated is handled and disposed scientifically as per the Rules without causing any adverse effect to human health and the environment.

5. The occupier is required to ensure that, discharge of liquid wastes is in compliance with the standard stipulated in schedule V of the Rules.
6. The applicant shall segregate the biomedical waste as per the Rules at individual ward level before handing over to common biomedical waste treatment facility.
7. The hospital authority/applicant shall start Biomedical Waste Management cell involving at least One Doctor, Nurse Superintendent and an Nurse fixing responsibility on each of the staff. The staff shall be chosen from different hierarchal levels and these staff shall undergo training on the details of biomedical waste management.
8. Hospital authority/applicant shall maintain the records and log book regarding generation and disposal of different categories of biomedical waste in the hospital on a day to day basis.
9. The Hospital authority/applicant shall earmark the Floor wise allotment of responsibilities for Bio-Medical Waste Management among staff and the same be displayed to the public.
10. The applicant shall display Charter on implementation of Bio-Medical Waste (Management and Handling) Rules, 1998 to the public in the hospital.
11. The applicant shall apply & obtain the Consent under Water Act & Air Act within one month time for the date of receipt of this authorization.
12. The Hospital Authority shall segregate Mercury waste from the Bio-Medical stream and same shall be stored in a secured place before its disposal as per relevant statute.
13. The applicant shall display this authorization as a prominent place like reception /entrance.
14. The applicant shall ensure compliance to all the applicable provisions of Bio-medical Waste (Management and Handling) Rules, 1998.
