CIRCULAR

Sub: Restricted Entry of Automobiles

As a part of green campus initiative and to maintain academic ambience and also to ensure safety in the campus, restricted entry of automobiles has been implemented in the campus. This is for the strict compliance by all teaching and non-teaching faculty and students.

The following measures have been implemented in the campus:

1. Entry of private/public vehicles have been restricted in the campus.

2. Pole barriers (boom barrier/boom gate) at entry and exit points have been installed and security guards have been appointed to restrict entry of automobiles in the campus.

3. A parking area exclusively for vehicles of patients/attenders has been allotted outside the campus.

4. A separate parking space for every faculty has been provided and their vehicles will be allowed only upto the designated parking area. Entry beyond that point has been strictly prohibited.

5. A separate parking area for differently abled people has been designated in the hospital

premises.

- 6. Differently abled faculty/students are permitted to get themselves dropped near to the work place/class.
- 7. Entry of heavy vehicles in the campus is banned.
- 8. Students in hostels are prohibited from having vehicles in the campus.

9. Bicycles of students and faculty are permitted in the campus.

10. Security guards are appointed at the parking areas for security of the vehicles in the parking areas.

11. Ambulance is allowed in the campus.
