### RESOURCE MOBILIZATION POLICY

The Resource Mobilization Policy focuses on achieving the goals and objectives of the University ensuring accountability and transparency. The Institution has a transparent and well-planned Financial Management System. The major sources of funds are Tuition fees, other fees, Research Grants by Government agencies (ICMR, DRDO, DST, VGST-GoK etc.). Revenue generated from the Hospital and Laboratory facilities, Consultancy programs and Donors (Individuals, Philanthropists, Alumni, etc.)

The institution is a non-profit, self-financing institution Deemed to be University governed by Board of Management, which ensures the resources generated are utilized for the purpose of academic activities of the institution as per UGC norms. The harmonized Governing Body coordinates and monitors the optimal utilization of the funds for the promotion of learner-centric ecosystem.

A Finance Committee Manages funds. The funds received for Research from Government Agencies are taken care by the respective coordinators with the help of University Finance Department.

The University provides Funds to;

- Meet the infrastructure requirement while starting new programmes and centers.
- Conduct academic activities such as Seminars, Workshops, Expert Talks, Association Activities, Faculty Development Programmes, etc.
- Extracurricular activities of students; a major concern and adequate funds are provided for Sports and Cultural activities.
- Award Scholarships and Freeships to the deserving students
- Provide Employee Provident Fund (EPF), Gratuity, Employee State Insurance (ESI), Group Savings Linked Insurance (GSLI), Employee Credit Society Loans and concessional medical care benefits apart from salary to non-teaching staff.
- Provide Gratuity, Free medical care including dependents and Research incentives apart from salary to teaching staff.

Revenue accrued through Tuition fees and Hospital operations is used for the infrastructure and academic activities. Funds granted by Government agencies are optimally used for which they are sanctioned.

Transparency and Accountability of Funds generated and utilized are ensured by conducting Annual Internal Audit of the Accounts.
