NRI/PIO/OCI category:

Eligibility:

1. The candidates, whose names are appearing in the “**Eligible Candidates List For Deemed University Stray Vacancies Round**” published by the MCC on their website www.mcc.nic.in on 07-01-2021.
2. The candidates, who have submitted their NRI documents with the MCC and changed their category / nationality from General / Indian to NRI.
3. Candidates who wish to change their Nationality from Indian to NRI can also approach the University office on or before 08-01-2021, with requisite NRI documents (i.e. **1).** Sponsor's Passport / VISA / Resident VISA, **2).** Embassy certificate of the sponsor, **3).** Sponsorship affidavit (stating that sponsor is responsible to bear the expenses for the whole duration of study), **4).** Relationship certificate / affidavit (by both from Candidate and the Sponsor stating the relation of candidate with the sponsor), **5).** Income Tax Documents required as per the Income Tax Act 1961, of the sponsor.)
4. **Desirous eligible candidates are requested to report to the BLDE (DU) Admission Office in Vijayapura, Karnataka on or before 08-01-2021, by 5.00 pm with requisite original documents, shall be considered for Admission under NRI quota.**

Fee Structure:

Fee : USD equivalent INR 25,00,000/- per year **payable from the sponsorer's Foreign / Indian NRE bank account.** Apart from that admission processing fees of Rs. 15000/- payable one time, shall be paid at the time of admission and hostel fees and food charges approximately Rs. 1,25,000/- per year, shall be paid at the time of joining.
