ADMISSION NOTICE FOR STRAY VACANCY COUNSELLING

ADMISSION FOR MBBS COURSE 2021-22

1. Stray Vacancy Counselling cum Admission Procedure on 08-04-2022:

*The seats remaining vacant after MCC Mop-Up counselling shall be filled by the eligible candidates from the list of the “**Eligible Candidates for Deemed Stray Vacancy Round**” to be published by the DGHS / MCC on their website i.e. (www.mcc.nic.in) are eligible for this counseling, to be conducted by the BLDE(DU) as per the guidelines of DGHS/MCC.*

Desirous candidates can report physically along with either of the parent at the venue as per the schedule with requisite fees and original documents listed below and need to fulfill the following terms and conditions to complete the admission process.

- The physical presence of the candidate and either of the parents is mandatory.
- Prescribed fees in the form of RTGS /NEFT/ Net-Banking shall be paid. Candidates willing to pay through Demand Draft (DD) can take in favour of “**The Registrar, BLDE (Deemed to be University)**”, payable at **Vijayapur**
- Candidates willing to do RTGS / NEFT / Online transfer shall make all prior arrangements for the same and they shall bring the updated bank passbook which is showing the sufficient balance, Cheque book and consult the banker for the process. **Once the allotment is done, they have to make payment immediately through RTGS / NEFT etc. on the same day i.e. 08-04-2022, by 4.00 pm, otherwise the seat allotted get cancelled.**
- Original documents shall be produced as per the list shown below.
- Candidate and Parents together required to submit the affidavit as shown in the Annexure-IV.
- **The admissions will be granted to the candidates on the basis of inter-se merit amongst the candidates present on the said date and time. No cancellation will be entertained after this admission.**

Note: The above fee does not include Hostel & Mess fee. It is approximately Rs. 1.00 lacks per annum and it has to be paid at the time of joining the course. This fee may increase 5% to 10% yearly.

7. IMPORTANT NOTE (Please read this information):

- Candidate in person along with parent, Original Documents and prescribed fees are mandatory for attending the counseling.
- Candidates shall register their names in the attendance register at the venue for counseling and admission process; the seats will be allotted only on inter-se merit among the registered candidates.
- **Candidates reporting / registering after 11-00 am on 08-04-2022 will not be considered for stray counselling even if they have got Higher Ranking. However if the number of candidates registering are less, then they may be considered at the end of counseling.**
- Candidates attending counselling shall satisfy the eligibility requirement as per the NEET Information Brochure 2021 and the minimum eligibility requirements as prescribed by the NMC/MCI of India regulations for admission to UG Medical course.
- There will be active verification of the NEET All India Rank (UR) submitted by the candidate with the information available in the NEET / MCC website (cbseresults.nic.in / mcc.nic.in). Candidate whose NEET all India rank does not match will be disqualified for the counselling process.
- **Part payment or payment in installment is not permitted. Non-payment of the first year fees on the day of counselling will result in instantaneous forfeiture of seat.**
- Differences of opinion & disputes arising in the interpretation & implementation of the clauses in the brochure, if any, will be referred to the Competent Authority and same will be informed to the Vice-Chancellor of the BLDE (Deemed to be University), Vijayapura and his decision shall be final & binding on all the concerned.
- Any legal matter arising out of the total admission process of MBBS course through BLDE (Deemed to be University), Vijayapura will be in the courts of VIJAYAPURA, Karnataka State.
- BLDE (Deemed to be University), Vijayapura does not have any agents, liaison / admission offices, representatives or any other office/s other than the office mentioned in this brochure.

- Candidates are requested not to depend upon or deal with any person or organization/s claiming to be associated with the BLDE (Deemed to be University), Vijayapura activities or claiming to help with admission. BLDE (Deemed to be University), Vijayapura will not be responsible for the same.
- In case any candidate is found to be involved in or indulged in impersonation or any other unfair means or cheating to procure admission, BLDE (Deemed to be University), Vijayapura reserves the right to cancel the allotted seat and forfeit of the entire amount of fees paid by such candidate. Such candidates are liable for prosecution as per the law of the land.
