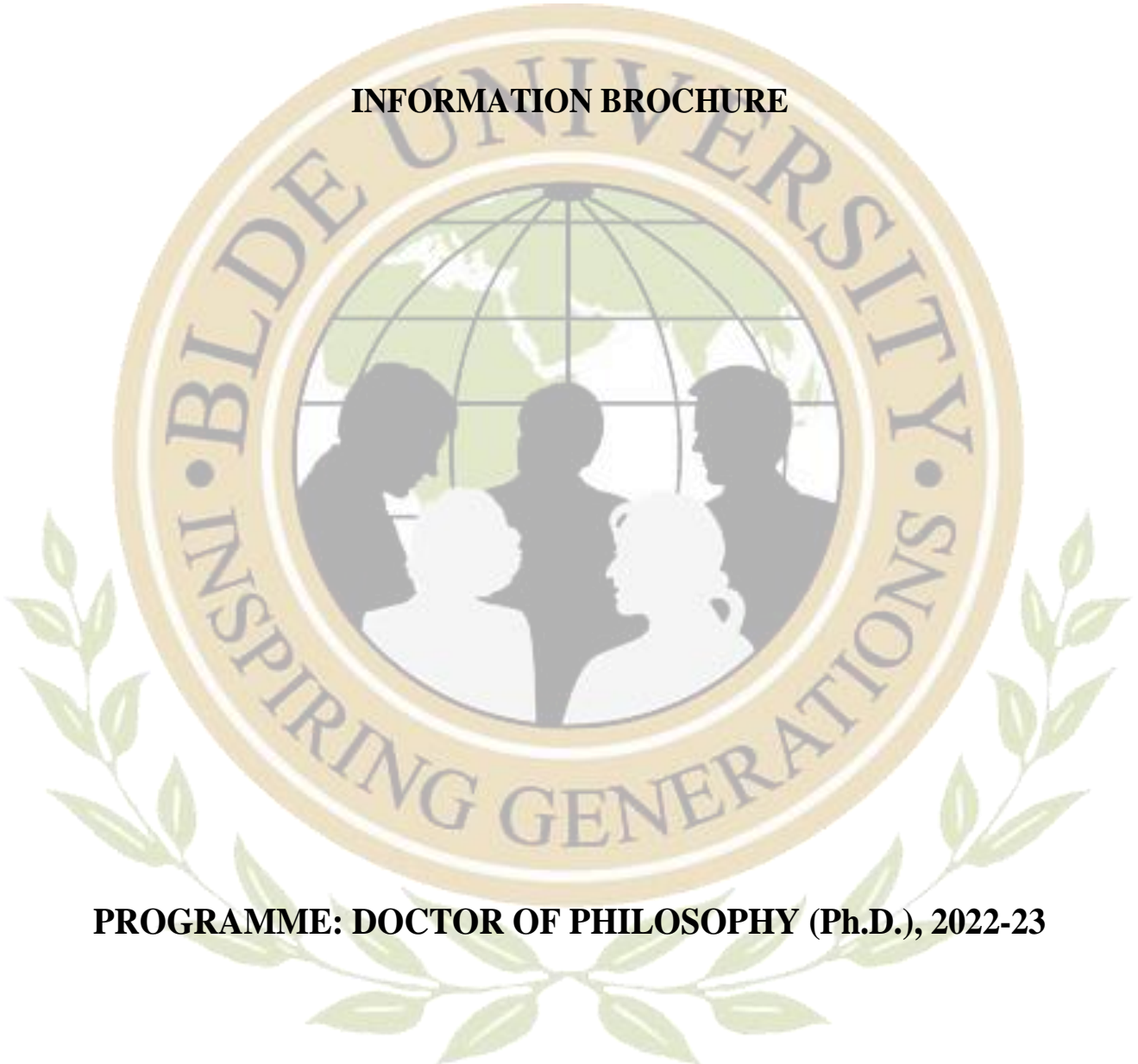

**PROGRAMME: DOCTOR OF PHILOSOPHY (Ph.D.), 2022-23**

**Preamble:** The Ph.D. Programme of this Deemed to be University is governed by the BLDE (Deemed to be University) Ph.D. Revised Regulations-2019, which is in conformation with UGC (Minimum Standard and Procedure for Award of M.Phil./Ph.D. Degrees) Regulations, 2016 (1<sup>st</sup> amendment 2018 & 2<sup>nd</sup> amendment 2019).

**Ph.D. Programme:** BLDE(DU) offers admission to Ph.D. programme in various medical disciplines under the Faculty of Medicine and Faculty of Allied Health Sciences. The various disciplines are listed below:

## 1. Eligibility:

- 1.1 A recognized **qualifying higher specialty postgraduate degree/diploma** is essential with a minimum of 55% of the aggregate marks (45% in case of SC/ST/OBC (non-creamy layer)/Differently Abled Candidates) in the qualifying examination. Candidates with the following qualifications are eligible for registering for the **Ph.D. (Medical & Allied Health Science)** Degree.
  - 1.1.1 Candidates with MD/MS in different specialties recognized by Medical Council of India & its Amendments thereof Candidates with super specialty degrees D.M. Doctor of medicine, and M.Ch., Master of Chirurgiae, recognized by Medical Council of India & its amendments thereof.
  - 1.1.2 Candidates with MD/MS, MRCP/FRCS (granted in UK on or before 11.11.1975 as per MCI Act 1956, second schedule) or equivalent Master's degree awarded by a College/University recognized by MCI are eligible to register for Ph.D. Programme in their subject of specialization.

- 1.1.3 Post Graduate Diploma in different Specialties: D.C.P., D.Ch., D.O., D.Ortho, D.L.O., D.G.O., D.A. or any other postgraduate diploma recognized by Medical Council of India & its amendments thereof.
- 1.1.4 Candidates with qualification of Diplomate of the National Board, D.N.B. in specialties/super-specialties held by the National Board of the Examination after completion of the prescribed period for eligibility to be considered equivalent to M.D. / M.S as per the norms and approved by the MCI/ Governing Council of this University as equivalent thereto.
- 1.1.5 Candidates with M.B.B.S. Degree, recognized by Medical Council of India & with Three years of Teaching / Clinical / Laboratory Experience after the completion of the degree.
- 1.1.6 Candidates with M.Sc. (Medical) - Anatomy, Physiology, Microbiology, Biochemistry and Pharmacology are eligible to register for Ph.D. Programme in the Faculty of Medicine.
- 1.1.7 Candidates who have qualifications from M.Sc. in any branch of Life Sciences, M.Sc. in Medical Physics/Biophysics, M.Sc. in Nursing Sciences, M.Pharm/Pharm.D., M.Sc. Biotechnology, M.Sc. in Human Genetics, MPH and MHA are eligible to register for Ph.D. Programme in Allied Health Sciences.
- 1.1.8 The above **qualifying degrees** should be from the Faculties of this Deemed to be University or any other University recognized by the Association of Indian Universities, Medical Council of India, and other approved recognized Scientific Bodies of the Government of India, etc., and approved by the Academic Council/ Board of Management of this University for Provisional Registration for the Ph.D. programme.

## 2. Mode of Selection of Candidates:

The selection of the candidates will be based on the merit obtained in the '*BLDE(DU) All India Entrance Examination-2022*' and on the performance of the candidates during the interview to be conducted by the Ph.D. Committee.

Provided that, for selection of candidates, a weightage of **70%** to the **entrance test** and **30%** to the **performance** in the **interview/viva-voce** shall be given.

## 3. Course Work and Examination:

- 3.1 The credits assigned to the Ph.D. course work shall be a minimum of eight (08) credits and maximum of sixteen (16) credits. All the registered Ph.D. Scholars shall be required to complete the Course Work prescribed during the initial one (01) year as per UGC Regulations, covering the topics mentioned in the syllabus of the Ph.D. Programme.
- 3.2 The Candidate shall have a minimum of 75% attendance during the Course work. At the end of the Course Work, there will be a Pre-Ph.D. Course work examination.
- 3.3 The Candidates have to secure a minimum of 55% of the marks, in Theory Papers separately in each Paper and in Viva-voce in the Pre-Ph.D. Course Work Examination.

#### 4. Duration of the Programme:

The duration of the programme shall be for a minimum period of Three (03) years including Course Work and a maximum of Six (06) years from the date of registration.

#### 5. Fee Structure:

The application can be downloaded from our website and submit the duly filled application along with requisite documents accompanied with a crossed Demand Draft (Nationalized Bank) of **Rs.2000/-** drawn in favor of **The Registrar BLDE (Deemed to be University), Vijayapura, Karnataka.**

## 10. Terms and Conditions:

- The Research Scholars shall strictly adhere to the existing Rules and Regulations of the Ph.D. Programme of the BLDE (Deemed to be University).
- The BLDE(DU) will not bear any expenditure towards conduct of the research work, which has to be borne by the individual, but can use the available physical infrastructure and library facility.
- The Research Scholars are not permitted to register for any other academic programme of Indian/Foreign University during the tenure of the Ph.D. Course.
- The Research Scholars shall attend all the seminars and orientation programmes conducted by the BLDE(DU) and its Departments relating to their research topic/project.
- A separate logbook needs to be maintained by all the Research Scholars and the same should be made available as and when required by the Institution.
- The Research Scholars working in any of the BLDE Institutions are required to give an Undertaking to the effect that they shall serve the BLDE Institution at least for a minimum period of two years after the completion of their Ph.D. Programme.
- In case the Research Scholars wish to discontinue the programme, their registration gets canceled and such Research Scholars are liable to pay the entire course fee.
- In case the full-time Research Scholar who receives the financial assistance from BLDE(DU), fails to continue the Ph.D. programme, he/she shall refund the entire amount to the Institution.
- Full-time Ph.D. Research Scholars may be assigned work upto 6 hours per week by the Principals / HoD of respective departments.
- Change of workplace shall not be permitted during the Ph.D. Course.
