The results and cut-off scores of NEET PG - 2022 have been declared by NBE on 14.03.2023 and can be viewed at National Board of examination (NBE) website <https://nbe.edu.in>.

NEET-PG 2023 candidates with scores at or above cut-off scores displayed on the NBE website in their respective categories, are eligible to participate in the counseling for admission to PG Medical (MD/MS) seats to be conducted by Medical Counseling Committee (MCC) of Director General of Health Services (DGHS), Ministry of Health & Family Welfare (MoHFW).
