Preamble: The Ph.D. Programme of this Deemed to be University is governed by the BLDE (Deemed to be University) Ph.D. Revised Regulations-2019, which is in conformation with UGC (Minimum Standard and Procedure for Award of M.Phil./Ph.D. Degrees) Regulations, 2016 (1st amendment 2018 & 2nd amendment 2019).

Ph.D. Programme: BLDE(DU) offers admission to Ph.D. programme in various medical disciplines under the Faculty of Medicine, Faculty of Allied Health Sciences and Faculty of Science & Technology. The various disciplines are listed below:

a) Faculty of Medical Sciences

Ph.D. in any given subject of Medical Sciences as approved and notified by the National Medical Commission from time to time (Pre, Para, Clinical, Broad Specialty & Super Specialty Subjects)

Anatomy| Physiology| Biochemistry| Pharmacology| Pathology| Microbiology| Forensic Medicine & Toxicology| Community Medicine| General Medicine| General Surgery| Obstetrics and Gynecology| Orthopedics| Ophthalmology| Otorhinolaryngology (ENT)| Pediatrics| Dermatology| Radiology| Anaesthesiology| Emergency Medicine| Psychiatry| Respiratory Medicine and any other subjects introduced from time to time.

b) Faculty of Allied Health Sciences

- Life Science (Biotechnology| Biochemistry| Cell Genetics| Microbiology| Molecular Biology| Molecular Genetics).
- Medical Laboratory Science (Cytotechnology| Forensic Science Technology| Histotechnology| Hemato Technology| Medical Lab Technology).
- Nutrition Science (Dietics| Clinical Diatic| Food Service Dietics| Public Health Nutrition| Sports Nutrition).
- Community Care (Community Health| Environmental Health).
- Behavioral Health Science (Psychology| Behavior Health, Mental Health).
- Physiotherapy and any other subjects introduced from time to time.

c) Faculty of Science & Technology

Chemistry| Biochemistry| Microbiology| Biotechnology and any other subjects introduced from time to time

1. Eligibility:

- a) A 1-year/2-semester master's degree programme after a 4-year/8-semester bachelor's degree programme or a 2-year/4-semester master's degree programme after a 3-year bachelor's degree programme or qualifications declared equivalent to the master's degree by the corresponding statutory regulatory body, with at least 55% marks in aggregate or its equivalent grade in a point scale wherever grading system is followed or equivalent qualification from a foreign educational institution accredited by an assessment and accreditation agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country to assess, accredit or assure quality and standards of the educational institution.

A relaxation of 5% marks or its equivalent grade may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/Differently-Abled, Economically Weaker Section (EWS) and other categories of candidates as per the decision of the Commission from time to time.

- b) Provided that a candidate seeking admission after a 4-year/8-semester bachelor's degree programme should have a minimum of 75% marks in aggregate or its equivalent grade on a point scale wherever the grading system is followed. A relaxation of 5% marks or its equivalent grade may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/Differently-Abled, Economically Weaker Section (EWS) and other categories of candidates as per the decision of the Commission from time to time.
- c) Candidates who have completed the M.Phil. programme with at least 55% marks in aggregate or its equivalent grade in a point scale wherever grading system is followed or equivalent qualification from a foreign educational institution accredited by an assessment and accreditation agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country to assess, accredit or assure quality and standards of educational institutions, shall be eligible for admission to the Ph.D. programme. A relaxation of 5% marks or its equivalent grade may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/Differently-Abled, Economically Weaker Section (EWS) and other categories of candidates as per the decision of the Commission from time to time.

2. Mode of Selection of Candidates:

The selection of the candidates will be based on the merit obtained in the '*BLDE(DU) All India Entrance Examination-2023*' and on the performance of the candidates during the interview to be conducted by the Doctoral Research Committee.

Provided that for selection of candidates, a weightage of **70%** to the **entrance test** and **30%** to the **performance** in the **interview/viva-voce** shall be given.

3. Course Work and Examination:

- 3.1 The credits assigned to the Ph.D. course work shall be a minimum of eight (08) credits and maximum of sixteen (16) credits. All the registered Ph.D. Scholars shall be required to complete the Course Work prescribed during the initial one (01) year as per UGC Regulations, covering the topics mentioned in the syllabus of the Ph.D. Programme.
- 3.2 The Candidate shall have a minimum of 75% attendance during the Course work. At the end of the Course Work, there will be a Pre-Ph.D. Course work examination.
- 3.3 The Candidates have to secure a minimum of 55% of the marks, in Theory Papers separately in each Paper and in Viva-voce in the Pre-Ph.D. Course Work Examination.

4. Duration of the Programme:

The duration of the programme shall be for a minimum period of Three (03) years including Course Work and a maximum of Six (06) years from the date of registration.

5. Fee Structure:

The application can be downloaded from our website and submit the duly filled application along with requisite documents accompanied with a crossed Demand Draft (Nationalized Bank) of **Rs.2000/-** drawn in favor of **The Registrar BLDE (Deemed to be University), Vijayapura, Karnataka.**

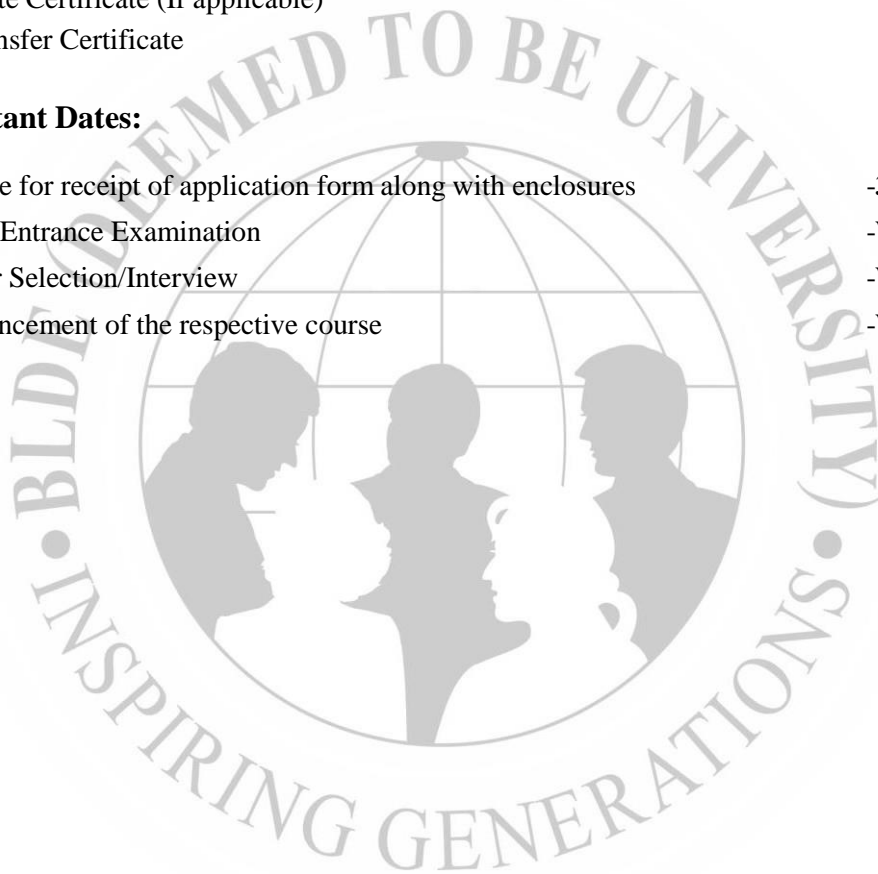

10. Terms and Conditions:

- The Research Scholars shall strictly adhere to the existing Rules and Regulations of the Ph.D. Programme of the BLDE (Deemed to be University).
- The BLDE(DU) will not bear any expenditure towards conduct of the research work, which has to be borne by the individual, but can use the available physical infrastructure and library facility.
- The Research Scholars are not permitted to register for any other academic programme of Indian/Foreign University during the tenure of the Ph.D. Course.
- The Research Scholars shall attend all the seminars and orientation programmes conducted by the BLDE(DU) and its Departments relating to their research topic/project.
- A separate logbook needs to be maintained by all the Research Scholars and the same should be made available as and when required by the Institution.
- The Research Scholars working in any of the BLDE Institutions are required to give an Undertaking to the effect that they shall serve the BLDE Institution at least for a minimum period of two years after the completion of their Ph.D. Programme.
- In case the Research Scholars wish to discontinue the programme, their registration gets canceled and such Research Scholars are liable to pay the entire course fee.
- In case the full-time Research Scholar who receives the financial assistance from BLDE(DU), fails to continue the Ph.D. programme, he/she shall refund the entire amount to the Institution.
- Full-time Ph.D. Research Scholars may be assigned work upto 6 hours per week by the Principals / HoD of respective departments.
- Change of workplace shall not be permitted during the Ph.D. Course.
