- **g.** Start-ups and Innovations Dean FOM, emphasized about the participation of students in Hackathon after their examinations.
- **h.** Number of Patents / Copyrights There is need to improve in Number of patents & copyrights.
- **i.** Students benefited by scholarships / free ships / fee-waivers The details of scholarships, free ships and fee-waivers to be procured from finance office.
- **j.** Activities on career advancement and Placement Pre placement activities and career advancement activities are in progress.
- **k.** Institutional Vision and Leadership To be procured from Registrar office.
