- 2. Meetings: The committee compulsorily shall meet every quarterly and also as & when required. Further, the Committee has to conduct the awareness programmes quarterly and also as directed by UGC separately for Students/ Faculty/ Non-Teaching Staff (All Male & Female) in a year on regular basis and submit the report to University without fail.
- **3. Quorum:** Not less than 6 with at least two female members present during the meeting.
- **4. Reporting:** The committee shall report directly to the Vice-Chancellor of the University.
- 5. Limitations: The committee shall submit the report on the complaints received on the sexual harassment within 30 days of complaints received, along with its recommendations.
- **6.** Validity: The committee is valid for the period of Three (03) years.
