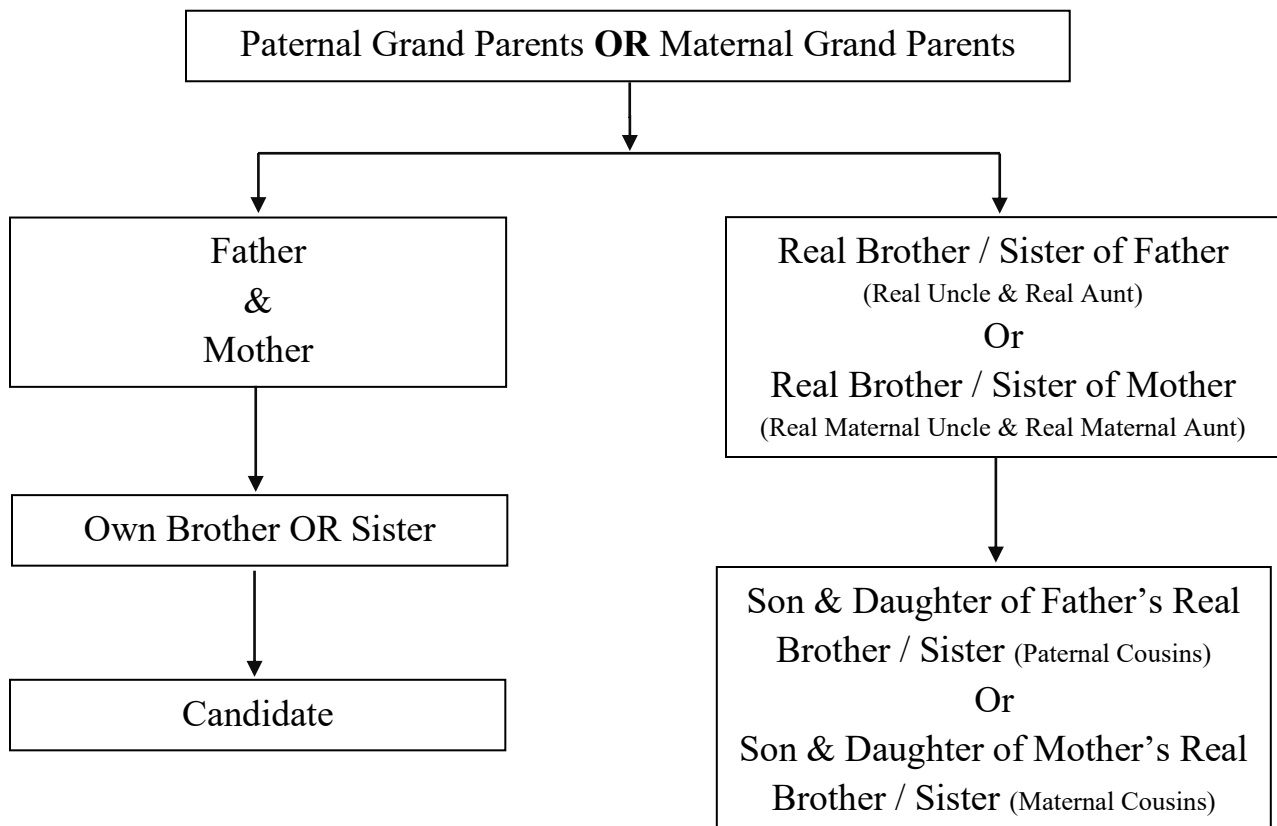

NOTE ON NRI / PIO / OCI / SPONSORED ADMISSION

1. GUIDELINES OF RELATIONSHIP BETWEEN CANDIDATE & SPONSORER:

The candidates intending to apply for admission under the NRI quota, are to satisfy the following terms and conditions regarding their eligibility under NRI quota and sponsorship etc. as per the guidelines issued by the Hon'ble Supreme Court of India, under it's order dated 22-08-2017 passed in W.P.(c) No. 689/2017-Consortium of Deemed Universities in Karnataka (CODEUNIK) & another V/s Union of India & Ors.

2. GUIDELINES OF FEES PAYMENT FOR NRI CANDIDATE:

NRI candidate, fee payment shall be from the Sponsorer foreign account (**such remittance should be accompanied by SWIFT Message, transaction details & Bank Statement of the transaction**) **OR** they can also pay the equivalent Indian Rupees from the Indian **NRE bank account of the Sponsorer**. However, this transaction shall be supported by a letter from the Banker stating that the amount is from the NRE account of the Sponsorer **and NRE Bank Account Pass Book / Bank Statement shall be produced.**

NRI candidates are advised to pay the fees to the following bank account and proof of remittance can be produced along with original documents, at the time of physical reporting / admission as per MCC reporting schedule:

3. GUIDELINES OF DOCUMENTS REQUIRED FOR NRI CANDIDATE:

All relevant **Original NRI documents** as per MCC instructions are must and additional original documents, especially to prove the relationship (First degree relatives of NRI wards as per MCC Guidelines) of the candidate with the sponsor, unless and until the relationship is not proved the admission process will not be completed.

If the candidate and parents are sure about the relationship (between Candidate and Sponsorer) Kindly initiate the fees payment from Sponsorer's foreign account or Indian NRE bank account at the earliest. Because foreign transactions take a minimum of 2-3 working days. Unless and until we receive the fees in the University Bank account within the stipulated time, as per MCC Counselling Schedule, the admission process will not be completed.

The candidate and parent shall note that the fees for all the years, has to come from the sponsor Foreign account or Indian NRE bank account.
